Dear Mr. Brundage:

I refer to our exchange of correspondence during August, 1956, with regard to the establishment of a Senior Executive Pay Scale for the Central Intelligence Agency.

You will recall that in my letter of 17 August 1956 I advised you that I might later designate a fourth Deputy Director. In commenting on a report made to the President by his Board of Consultants on Foreign Intelligence Activities, I advised the President that I proposed to designate a Deputy Director for Coordination who would be responsible for the continuous study and review of possibilities for increasing integration, reducing duplication, and improving coordination within the national intelligence effort in consultation with representatives of other intelligence agencies.

The President has approved of this proposal and I have this date appointed General Lucian K. Truscott, Jr., USA (Ret), to this office.
