Dear Mr. Stans:

I am advised that H. R. 6141, the "Overseas Employees Health and Medical Services Act" has been adopted as an Administration bill and will receive appropriate consideration by the House Committee on Post Office and Civil Service.

I have been interested in the various proposals for overseas medical benefits for employees and their dependents for some time. Central Intelligence Agency representatives have participated in some of the discussions concerning these proposals and I have been following closely the development of the Administration's program. Our legislative proposals for 1956 included amendments to the Central Intelligence Agency Act providing medical benefits for Central Intelligence Agency employees and their dependents in overseas areas; however, these proposals were not acted upon by the 84th Congress.

H. R. 6141 would provide uniform medical benefits for all civilian employees of the U. S. Government and their dependents in overseas areas. The enactment of this bill would accomplish the same objectives which this Agency has sought in the past. Therefore, we support this bill as it fills a long-felt need in the field of overseas medical benefit legislation.

The provision of medical benefits to Central Intelligence Agency employees and their dependents through a program administered on a Government-wide basis will present security problems unique to this Agency. However, we feel that the language of the bill would permit us to resolve these problems through appropriate administrative procedures.

EXECUTIVE REGISTRY FILE *DeW. [unclear]*

Inasmuch as we have had considerable experience in our overseas medical program under existing authorities contained in the Central Intelligence Agency Act of 1949, I believe this Agency can make a substantial contribution to the proposed program. Accordingly, I request that upon enactment of this bill or similar legislation consideration be given to the appointment of a Central Intelligence Agency representative to the Overseas Advisory Board. Through this representation, we would be in a better position to anticipate and resolve possible security problems within the framework of the general regulations.
