
Paragraph 6 of National Security Council (NSC) Action 812-c, designated the Director of the Office of Defense Mobilization as the coordinating authority to prepare a Progress Report, in consultation with the Departments of State, Defense, Central Intelligence Agency, and other interested agencies, for submission to the Council or Planning Board by October 1, 1953, as to paragraphs 2, 4 and 5, and by January 1, 1954, as to paragraph 3 of NSC Action 812-c.

It is considered that the desired Progress Report can be drafted most effectively and expeditiously by an ad hoc group which includes representatives of the agencies charged by paragraphs 2 to 5, inclusive, of NSC Action 812-c with responsibility for the performance of certain actions toward the achievement of the four (4) basic objectives.

It is requested that you designate a member of your agency to participate in the task of the ad hoc group in drafting the Progress Report. The name of your member should be made available to my office not later than August 26.


