NSC Information

This is to confirm my request of 6 June 1955 through your liaison officer, Mr. S. J. Papich, that the FBI kindly conduct the investigation requested by the President at the NSC meeting on 26 May 1955 and confirmed in a memorandum from the Executive Secretary, NSC, subject as above dated 27 May 1955. This memorandum requests that the head of each department or agency represented at the 249th NSC meeting on May 19, 1955 for NSC Action No. 1402, will ask the FBI to conduct an investigation to determine whether the source of the unauthorized disclosure relating to that NSC action is in any way identified with or traceable to such department or agency, in order that appropriate administrative action may be promptly taken by the head of the department or agency concerned.
