I was recently informed by [redacted] that the [redacted] [redacted] which we have developed is an item on which the Bureau has been working for some time but without reaching the degree of success which we have achieved. It seemed to me, therefore, that it would be most desirable if you were to write a letter to Mr. Hoover along the lines of the attached, offering him and the Bureau access to this equipment which will undoubtedly be of considerable value and assistance to them. It seemed more appropriate for you to give the official notification than for this matter to be handled through routine liaison channels. We can afford to "take a bow" on this one.
