1. REFERENCES A AND B EXPRESSED CONCERN OVER OUR LACK OF INTELLIGENCE OF SOVIET ATOMIC ENERGY ACTIVITIES AND REQUESTED, OR SUGGESTED, REVIEW AND RECOMMENDATION AS TO HOW INTELLIGENCE IN THIS FIELD COULD BE IMPROVED. A PARTIAL REPLY WAS MADE TO THE JOINT INTELLIGENCE COMMITTEE MEMORANDUM BY MY MEMORANDUM OF 10 APRIL 1950, SUBJECT "INTELLIGENCE ON SOVIET ATOMIC ACTIVITIES", WHICH ALSO STATED THAT FURTHER STUDIES WERE BEING UNDERTAKEN.

2. ACTING UPON THE REQUEST CONTAINED IN REFERENCE A, I CONVENED AN AD HOC COMMITTEE WHICH HAS PREPARED A COMPREHENSIVE STUDY OF THE PROBLEMS OF ATOMIC ENERGY INTELLIGENCE.

3. COPIES OF THE REPORT OF THIS AD HOC COMMITTEE ON ATOMIC ENERGY INTELLIGENCE ARE NOW BEING TRANSMITTED TO THE NATIONAL SECURITY COUNCIL. A COPY IS ENCLOSED HEREWITH AS A REPLY TO THE JOINT INTELLIGENCE COMMITTEE MEMORANDUM OF 13 MARCH. A "TOP SECRET" VERSION WITH THE SENSITIVE INFORMATION CONCERNING SPECIAL INTELLIGENCE REMOVED IS AVAILABLE FOR USE IF DESIRED.

4. THIS REPORT WILL BE THE SUBJECT OF DISCUSSION AT THE INTELLIGENCE ADVISORY COMMITTEE MEETING AT 2:30 P.M., 16 JUNE 1950. MEMBERS OF THE AD HOC COMMITTEE AND THE PRINCIPAL PARTICIPANTS IN THE STUDY WILL BE PRESENT FOR THE DISCUSSION.
