(ASDIC)

1. Reference Armed Services Joint Intelligence Directive, subject: "Captured Enemy Documents" (SR 380-350-2, OPNAV Instr 0386.3, AFOIN-C/DD 350.09) and JIC 456/52, subject: "Planning Pertaining to Armed Services Document Intelligence Center."

2. A review of the planning status of ASDIC reveals that considerable planning and staff action remains to be accomplished to place this organization on a readiness basis. The planning required includes:

a. Completion of personnel requirements plans and phasing of these requirements for mobilization.

b. Determination of site location and physical facilities requirements.

c. Uniform operational planning and operational procedures.

d. Recommendations on reproduction facilities.

3. The intelligence exploitation of captured enemy documents is closely related to the exploitation of captured enemy personnel. A joint organization already exists for the latter purpose under the designation of the Army Security Center (ASC) and members from all three services and CIA are represented in the ASC directorate. It is considered logical, in order to assure continuity of planning and from the standpoint of both experience and knowledge of the problems involved, that these members be charged with continued planning for ASDIC, in addition to their other duties, until such time as ASDIC becomes operational.

4. Accordingly, the Assistant Chief of Staff, G-2, proposes to designate the present Director and Assistant Director (Army) of ASC as
