Dear General Donovan:

The War Report on the activities of the Office of Strategic Services, which was prepared at the request of the Joint Chiefs of Staff and under the supervision of the Joint Security Control, has now been completed.

It is my understanding that the History Staff consulted closely with you during its preparation, and that a major portion of the rough drafts were submitted to you as the work progressed.

Inasmuch as the Report covers the activities which you so ably directed, it is felt that it should be submitted to you in its final form for any desired comments prior to delivery to the Joint Security Control for further processing. Under the directive of the Joint Chiefs of Staff, the ultimate distribution and classification of the report will be decided by that body, in conjunction with the Joint Security Control. It is our thought, and we propose to recommend, that a classification of "Secret" should be maintained, and that distribution be limited to those Government agencies which might benefit from the experiences and the lessons learned.

I have directed [redacted], Adjutant of the Strategic Services Unit, to personally deliver and make arrangements for the return of a copy of the Report with your comments. Since we are being pressed daily by the Office of the Joint Chiefs of Staff for the completed work, your earliest attention will be appreciated.
