Dear Mr. Dulles:

It has come to my attention that certain departments are finalizing their budget estimates for Fiscal Year 1955; therefore, I desire to bring to your attention the question of financial support for the Interdepartment Radio Advisory Committee (IRAC).


For the Fiscal Years 1953 and 1954, the President requested in his letters of October 7 and November 13, 1952 that the financial support for the IRAC be on the basis of sharing the cost by the participating agencies. Fiscal Year 1955 was not covered because it was considered possible that other financial arrangements could be found. As of this writing, no alternate solution is anticipated.

In view of the need for making some provision for the IRAC, I suggest that each of the participating agencies include a tentative figure in its requirements for Fiscal Year 1955 in accordance with the following schedule. The basis for computation is the same as was used in my letter of October 9, 1952 to the participating agencies.

Department of the Army	\$ 40,000
Department of the Navy	40,000
Department of the Air Force	40,000
Department of Commerce	40,000
Department of State	6,500
Department of the Treasury	6,500
Department of Agriculture	6,500
Department of the Interior	6,500
Department of Justice	6,500
Central Intelligence Agency	6,500
Federal Communications Commission	6,500
TOTAL	\$205,500

The Interdepartment Radio Advisory Committee is in the process of preparing detailed estimates for fiscal year 1955 which will be available soon. Any resultant modifications will be communicated to you without delay.
