SUBJECT: Estimated Japanese Casualties in the China Area During Period 1937-1945 and Total Japanese Casualties in All Areas of the Pacific Theater During World War II

TO : Assistant Chief of Staff, G-2

1. Attached is a detailed report in reply to your radio request (DA 83286, dtd 13 Feb 51) for our estimated number of Japanese casualties in the China Area during the period 1937-1945 and the total Japanese casualties in all areas of the Pacific Theater during World War II. The attached documents, compiled by the First and Second Demobilization Bureaus, list the total known casualties by all causes during the period 7 December 1941 - 15 August 1945 and are the most accurate figures available.

2. A study of available Japanese records reveals that Japanese casualties from 1937-1945 were as follows:

3. Attention is invited to the large number of Japanese who perished in the Southwest Pacific Area during the course of World War II. The figure reached almost half of the grand total of Japanese killed in all areas of combat. The toll in the Philippines was particularly heavy. The figures for SWPA are as follows:



Note 1: The above number is the total of figures resultant from the investigation into eighteen kinds of documents concerning the deaths now kept by each Assistance Section, such as 'Roster of the Dead' and 'List of Ashes' prepared by each Assistance Section and the roster, etc., prepared and submitted by each City, Town or Village Office. 770 man-days were spent in the above investigation.

Note 2: Presumed number of deaths whose records of death do not exist in (b) above should be mentioned as 'about 50,000' but the results of summing-up was mentioned above intact.

Note : This table was prepared by investigating into the documents concerning the dead by each District Demobilization Liquidation Division and the results of which was summed up by the Second Demobilization Bureau Liquidation Division.

Note 1: Those who have taken proceedings for pension for functional impediments are the wounds stipulated in the Enforcement Regulations of Pension Law' of 1923--in short, functional impediments still left in the little finger of one hand or that in two toes of three toes except the first and second toes of one foot even after the medical treatment for more than three years.

Note 2: There may be a good many persons wounded slighter than above and the number of them can only be calculated based on presumption as this Bureau has no reliable data.

In the first report concerning the number of the wounded Navy Servicemen and Civilians, the Second Demobilization Bureau Liquidation Division has had the data with which the total of the wounded was presumed as many as 6.5 times as that of the pensioners. But with regard to the former Army there is no such data and it is unreasonable to apply above ratio of the Navy to that of the Army.

Should that ratio be applied the total of the wounded of the former Army would be about 340,000. Moreover it is impossible, for the following reasons, to apply the ratio of the killed and the wounded basing on the historical statistics in former wars to that of the Pacific War.

Note 3: The number of the wounded is exceedingly smaller than that of the deaths being totaled about 1,300,000, which is unprecedented.

This is probably resultant from the fact that the wounded succeedingly took part in the battles without having been evacuated and were killed in them or died after they had been wounded.

Note 4: The figures were the results of the investigation conducted by the Assistance Sections in each prefectural Government into all the documents concerned--eighteen kinds in all including the documents submitted by the offices of each city, town and village.

2,290 man-days were spent in this survey.

Note 5: The presumptive number in (b) above should be 'about 20,000' but the results of summing-up was mentioned above intact.
