
Dear Mr. McLeod:





Dear General Cabell:

Reference is made to your memorandum of September 3, 1954 addressed to the Secretary of State transmitting for comment a draft revision of NSC 123, "Evacuation of Selected Key Indigenous Persons from Danger Areas". In view of the fact that the Department's representative aided in the preparation of the draft, the Department wishes to make only two minor additions.

In the opening sentence of Part II, paragraph 5. b., after the expression "final lists and priorities", the following phrase should be inserted, "within the framework of the lists".

In the Analysis, Part I: 2, in listing the Regional Liaison Groups, Tokyo should be inserted after Manila, for the Tokyo Group was inaugurated on August 5, 1954.

In regard to the closing sentence in paragraph 3 of your memorandum, the Department calls your attention to Deputy Under Secretary Robert Murphy's letter of March 30, 1954 to the

of Mr. Edwin J. Madill, Assistant Director of the Office of Special Consular Services and Chairman of the Washington Liaison Group, as the Department's representative on the Inter-Agency Evacuation Committee and on the Political Sub-Committee.
