

MEMORANDUM TO: Brig. Gen. Edwin K. Wright  
FROM: Merritt K. Ruddock MKR  
SUBJECT: New Office Designation.

1. In accordance with our conversation, this confirms Mr. Wisner's approval of the designation of the new office as the "Office of Policy Coordination." For purposes of general discussion within the agency it will have the described function of "coordinating the national intelligence effort with national security policy as established by those agencies of the government responsible for the formulation of such policy."
