MEMORANDUM TO: ASSISTANT DIRECTOR FOR POLICY COORDINATION

FROM : Director of Central Intelligence

SUBJECT : Strategic War Plan for Covert Operations dated 4 April 1951

1. The subject document is approved except that paragraphs 5 and 11 must be brought into conformity with new paragraph 4, NSC 10/2 as proposed to the National Security Council on 9 April 1951 and approved by the Secretary of Defense.

2. It may be used as a working paper for coordination with the Joint Outline Emergency War Plan, but no copies will be permitted to leave this agency except in custody of CIA personnel, and none will be retained outside the agency files. In other words, it will be treated by this agency as war plans are treated by the Joint Chiefs of Staff.
