MEMORANDUM FOR: Director of Central Intelligence  
SUBJECT : Projected OSS TV Series

1. This memorandum suggests action on the part of DCI. Such requested action is contained in paragraph 12.
2. It has come to our attention that a certain Bill Eliscu, formerly aide to Colonel Glavin when the latter commanded the OSS in Italy, recently approached several television networks and independent film producers with the proposition of making documentary films of various of the OSS war-time exploits. Eliscu was allegedly identified and vouched for by a letter in his possession signed by a Henry Prescott, president of the organization known as the Veterans of the OSS, and written on the official paper of that society which carries on its letter-head the names of General William J. Donovan and other prominent personages. The letter purportedly states that Eliscu is authorized to negotiate such arrangements and proposes the production of a series of 39 television shorts of thirty minutes duration each.
3. As you are aware, General Donovan would be in a position to furnish a very considerable body of material from archives in his personal possession.
4. While we know that Eliscu's proposal was rejected by several major companies, he did succeed in interesting a New York Company known as Flamingo Films, about whose personnel, reputation, and previous activity we know little or nothing. The announcement that this company has, in fact, started production on such a series was published in the 14 November issue of the trade-weekly Variety (Tab B).
5. In the course of Eliscu's earlier rounds, his proposal came to the attention of Larry Lowman, now a vice-president of the Columbia Broadcasting System and at one time chief of Commo for

the OSS. Lowman, his curiosity piqued, called in John Masht, known by Lowman to be a friend of ours, and showed him the Prescott letter introducing Eliscu. Masht, in turn, brought the matter indirectly to our attention together with the advice that it was his understanding Eliscu had alleged personal acquaintance with you and implied, at least, your approval of the venture.

6. The success of the endeavor to arouse the interest of the television industry in such a proposal (although not in Eliscu's) is attested by a letter dated 29 August 1956 addressed by Leslie Harris, Vice President and General Manager of the Columbia Broadcasting System Television Film Sales Corporation, to one [redacted] an attorney with offices in the Southern Building in Washington D. C. The letter itself, which has reached us through secure channels, is attached (Tab A). In brief, it expresses Mr. Harris' very considerable interest in the proposition (if agreement can be reached to do such a series in cooperation with the Agency), and his own awareness of the sensitivity of the undertaking. It further suggests that "a meeting be arranged in the near future with Mr. Dulles or his close associates in the CIA to discuss the broad aspects of their public relations policy and to determine just how the relationship between the now defunct OSS organization and the present CIA should be handled." We are reliably advised that Mr. Harris, despite the announcement of the Flamingo production, is still interested in discussing the matter with us.

7. It is, of course, established practice of other U. S. government agencies to engage in public relations efforts through the medium of movie and television dramatization of actual episodes in which their personnel have participated in the course of their normally assigned duties. Such presentations ordinarily open with a brief announcement of the official sanction or sponsorship of the program by the Department concerned. Most notable of the television series currently showing (some of which have been continuously popular for several years) are:

- a. Navy Log--which opens with a display of the seal of the United States Navy.
- b. Federal Men--portraying the activities of the Secret Service of the Treasury Department.
- c. The West Point Story--sponsored by the Department of the Army.

Other similar shows have at various times been authenticated and sponsored by the Air Force, the Federal Bureau of Investigation, and others.

In addition to these authenticated documentaries, there are numerous popular series, commercially sponsored, depicting intelligence and other clandestine activities which carry with them no official authentication.

8. The objective of all such authenticated productions is the obvious one behind any public-relations or advertising program: to gain public support. Public support so far as official agencies of the U. S. Government is concerned is important from two points of view.

- a. As an incentive to recruiting personnel, and
- b. As it may be expected to influence favorably legislative support of the agency's program.

Such advantages might reasonably be expected to accrue to this Agency should we decide officially to support a presentation of the sort discussed.

9. As for the protocol which guides other agencies of our government in similar ventures, we have checked with the Department of Defense, and are advised that no formal regulations exist to authorize or control such activities, but that agreements are arrived at by informal and confidential discussion between responsible officials of the media and the agency concerned.

10. On the negative side, so far as this Agency is concerned, the possibility of over-stimulating public curiosity and providing excuses for criticism of or investigation into our present activities were the presentation in any way to be linked officially with the Agency is a danger which cannot be overlooked.

11. While it would not normally occur to us to interest ourselves in such activity, it is our belief that it would be preferable that any nation-wide exposition of the activities of the OSS be undertaken by a reputable company with our concurrence and assistance, rather than to be based upon the personal recollections and archives of any individual or group of individuals, or to be, or appear to be, endorsed by any other U. S. Government agency with which the OSS was affiliated or connected in the public mind. It seems possible that if Mr. Harris is, indeed, still interested in such a venture, an early announcement of the intent by the Columbia Broadcasting Company might operate to limit the sales market of the Flamingo productions to minor network or small independent stations.

It is therefore recommended that you, accompanied by such of your staff as you may desire, agree to meet personally with Mr. Harris at a convenient but early date with a view to considering favorably collaboration in the production of a television series and the furnishing of script material in return for which you may request the close collaboration of our own selected personnel in the interest of the Agency and of national security.


