



SUBJECT: Board of Inquiry for the Handling of Employees  
Imprisoned by Soviet or Satellite Communist States

1. A Board of Inquiry for the handling of employees imprisoned by Soviet or Satellite Communist States is hereby established. This Board will review each case in which it is suspected, or allegations have been raised, that an employee has been guilty of misconduct or has furnished information to the detaining authorities while in the custody of a foreign government.


2. The Board will review all evidence and make appropriate recommendations to the Director of Central Intelligence with reference to the following:

a. Whether the employee furnished classified information willingly or unwillingly, or offered aid or support of any type to the detaining authorities and whether his actions were not in the best interests of the Government.

b. Based on the results of a above and the circumstances of retention, recommend to the Director either to 1) clear the employee of all charges and restore to full duty; 2) to terminate the employee; or 3) recommend other action.

3. The Board will consist of the following members, not less than three of which must be present at any meeting:
