Suggestion - Distribution and Filing of FBIB Monitored Materials

1. [redacted] of the Foreign Broadcast Information Branch, OO submitted a suggestion dated 21 July 1948 to the Committee for consideration. A synopsis of the suggestion is as follows:

The Foreign Broadcast Information Branch had three clerks, CAF-3, assigned to duties consisting of distributing monitoring summaries and texts, teletype material, filing of monitoring belts and other minor duties. Before the recent adoption of a new type recording and transcribing machine their duties also included the chafing of dictaphone wax records. With the adoption of the new type recording machine the workload of the three clerks was reduced. Their work shifts were arranged so that one clerk was always on duty from 8:00 a.m. to 12 midnight, daily including Saturday and Sunday.

[redacted] suggested that two of the three clerks be released from their duties and assigned to some other section of CIA. The one remaining clerk would then work from 8:00 a.m. to 4:00 p.m. Monday through Friday and would maintain files of summaries, recordings, texts and teletype copy as well as stocks of supplies. He would also be responsible for distributing copy while on duty. During the hours that no clerk is on duty monitors would be required to distribute their own copy. [redacted] stated that no undue additional work would result for monitors as has been amply proven on days when clerks were off duty on account of leave.

2. The above suggestion was adopted by FBIB on 17 September 1948 and monitors on all shifts are distributing their own copy. As a result of the adoption of the suggestion two occupied positions have been eliminated from the table of organization for FBIB resulting in an estimated savings of \$4,086.00.

3. The Committee on Awards for Meritorious Suggestions at its meeting on 28 September 1948 approved, [redacted] suggestion. The Committee recommends that the Director sign the attached
