

Memo for record: Comment by Col Edwards, Exec. for I&S:
"1. No objection from a security standpoint is perceived to providing an article of approximately 300 words on the NIA. It should not, however, extend to the activities of the NIA as requested in the letter. An article of 300 words would provide scarcely more than an opportunity to cover the history of NIA and its general functions, starting with the President's letter of January 22, 1946 and carrying through to the Unification Bill and the creation of the NSC.
2. The Director will, of course, wish to decide whether, from a policy standpoint, his name should be appended as author or whether the article should come from the NIA itself.
3. A suggested reply to Mr. Vizetelly is attached."
