Dear Admiral Hillenkoetter:

I forward herewith two letters from [redacted] together with a number of other documents and letters which Mr. [redacted] forwarded to me for my information and guidance.

Please note from this correspondence that [redacted] believes his organization is being discriminated against in not being allowed to carry out certain activities in Russian occupied Korea, or in Siberia, and that he feels that the group he represents, [redacted] is better fitted to accomplish certain investigations than any other group of people.

While I make no pretence of being acquainted with the problems which you gentlemen of the Central Intelligence Group are being confronted, it may be of interest to you to know that I have been acquainted with [redacted] for some fourteen years, both in this country and in the Hawaiian Islands, and that I have found him thoroughly reliable personally and quite accurate in his predictions.

I became Captain of the Yard (Navy Yard) Pearl Harbor in 1933 and shortly thereafter met [redacted]

[redacted] benefit of the American government. As I recall it, I forwarded several such reports to the Office of Naval Intelligence in Washington, D. C. During the years which followed I have been in almost constant touch with [redacted] and have never found him to be inaccurate in the reports he has given me.
