

My dear Mr. Dulles:

Well, I hope you had a good trip in Europe. I was very much pleased with our trip, and things are certainly in great shape, and you and your "human dynamo" brother certainly deserve a lot of credit. I only hope that the same thing doesn't happen to our great Secretary of State that happened to our President and to Chancellor Adenauer. I have just had a letter from Anthony Eden, with whom I had a great visit, and I am telling him the same thing is going to happen to him if he doesn't slow down.


Really and truly, I don't see how Secretary Dulles does it. It seems that it would be impossible to keep up that speed that he has, and we certainly need him, because he, like yourself, is doing such a grand job.

We had Governor McKeldin of Maryland down here at the Governors Conference in Mobile. We had about seventeen of them. Governor McKeldin is such a grand and good fellow and he knows all about the property that Colonel Albert Ernest and his associates have at Waldorf, Maryland, which is just twenty-one minutes from the Capitol of the United States. That great multi-million-dollar Highway 301 runs right through this tract of between seven and eight thousand acres, which is the prettiest land I have ever seen in that part of the country. Also, there are about four and a half miles of this same property on a branch of the Pennsylvania Railroad there.

I have talked to Colonel Albert Ernest, who was in New York, visiting the President of his Company, Mr. Roy Ferguson, President of the St. Regis Paper Company, a great friend of yours, as well as the President's friend. Colonel Ernest and his associates say they will be delighted to give you for your great building as much land as you need -- free, of course, without one cent. I understand you will need anywhere from ten acres to sixty acres. He will give it to you on this new road, which has been completed, through this property; he will give it to you on the Pennsylvania Railroad, or both,


