Dear Mr. Durham:

In connection with the search for the best site for the new headquarters installation for the Central Intelligence Agency we have surveyed over 30 properties, both Government and privately owned. Many people wrote in suggesting that they had property available, and we considered those in each instance. One of our basic criteria was the need to be within 10 miles or 20 minutes driving time from the White House. Therefore we did not consider the school at Olney as this was outside of our proposed radius. It is my understanding that the Olney school site is privately owned and is leased by the Government until 1956. We have had no indication that the owner or his agent wished to submit this property for our consideration.

I deeply appreciate your expression of pride in the development of CIA, and your more than kind comments concerning all of us here. I hope we will never give you any reason to think otherwise. We are trying every day to make a better record because we feel, in our business, that we can never level off -- we must always strive to get more and better intelligence.

I hope that when you come back from Geneva you will be passing through Washington and can stop and have lunch with us. It will give us an opportunity to bring you up to date on some of the things we are doing.
