Dear Mike:

With reference to your telephone call concerning [redacted] I have checked into the matter and learned the following.

[redacted] originally applied for a position with us in October 1950. At that time no position happened to be available which fitted his qualifications. Subsequently however, in the latter part of 1951 his case was reconsidered and he was offered a position in January 1952, which he initially accepted. Shortly thereafter by telephone he notified us that he was no longer interested in the job.

In May 1952 he reapplied for a position but at that time we again had nothing suitable. Between May 1952 and February 5, 1955 we heard nothing from [redacted]. On the latter date he sent us a letter applying for a position and on 10 February our Personnel office answered his letter, sending him certain forms to execute in order to bring his file up to date. Upon receipt of this material from [redacted] we will again make a thorough check and see if we can locate something for him.


