Dear Senator Gillette:

I have given considerable thought to your request dated July 7, 1955, for information concerning the estimated cost to the Central Intelligence Agency of the security processing of personnel pursuant to Executive Order 10450, and feel that as an aid to your Committee I can provide you with certain information which would be consistent with my responsibility as Director of Central Intelligence.

In this connection I would like to first point out that the issuance of Executive Order 10450 necessitated no additional cost to this Agency since we have always required investigations and appraisals of applicants and employees under our own security standards and procedures which are at least equivalent to those established by Executive Order 10450.

Insofar as administrative, adjudicative, and investigative expenses are concerned, it costs approximately \$177.25 to process an average employee case pursuant to Executive Order 10450. Cases of non-governmental employees are investigated for approximately \$140.12 for individuals requiring Top Secret clearance and \$15.58 for those requiring less than Top Secret clearance.

External investigative costs of this Agency were limited during Fiscal Year 1955 to reimbursements to the Civil Service Commission at an average cost per case of \$239.38 for certain investigations conducted by them. These investigations were

limited to cases where time and security permitted and involved only investigations of char and guard force personnel employed by the General Services Administration and assigned to buildings occupied by the Central Intelligence Agency.

With respect to costs attributable to the military, I would like to advise that this category is not applicable to this Agency since we have no military personnel assigned to the security program.

The only other expense incurred in connection with the processing of cases pursuant to Executive Order 10450 which you might consider applicable is the cost of the operation of the polygraph program which is applied on a restrictive basis in the Agency due to the particular sensitivity of our operations. However, since at your request you have been briefed concerning our polygraph program and since I do not consider the use of the polygraph as being a requirement of Executive Order 10450, I am not including information concerning it as being pertinent to your inquiry.
