

MEMORANDUM FOR: Deputy Director of Central Intelligence

SUBJECT : Official Lectures



1. In keeping with your request, I submit the following information relative to lectures which I have made at the direction of Admiral Hillenkoetter at various places throughout the country.

2. The following is a chronological list of official lectures which I have made in the capacity of official representative of the Director of Central Intelligence:

3. On each of the above occasions, even though the addresses were presented under different titles in keeping with the decision of the particular institution, the substantive content of my remarks was along the following outline:

- a. Background of intelligence picture at national level prior to advent of C.I.A.
- b. Top relationships between C.I.A. and national policy levels.
- c. Broad operating functions and responsibilities of C.I.A.
- d. Observations on particular aspects of the operations of C.I.A.
  - (1) The IAC and its performance.
  - (2) "Departmental Intelligence" and "National Intelligence."
  - (3) Non-duplication of functions carried on at the National and Departmental levels.
  - (4) Need for operational information.
  - (5) CIA is not an incipient Gestapo.
- e. Internal organizational structure of C.I.A.
  - (1) Staff activities.
  - (2) Operating offices (overt).
  - (3) Clandestine operations.
- f. General evaluations.
  - (1) The problem of coordination.
  - (2) U.S. Intelligence vs. Soviet Intelligence.
- g. Conclusion.
  - (1) Optimistic ending on progress being made in the intelligence field.

4. In each instance the presentation has been followed by a question and answer period.

5. Admiral Hillenkoetter has already informed the following institutions that I would be the C.I.A. spokesman on the dates indicated.
