MEMORANDUM FOR: Mr. Dulles

The attached report represents an exceedingly careful survey of East-West Trade activities of CIA. It concludes that at a cost of approximately [redacted] the Agency is fulfilling its responsibilities in this field. The report recommends:

- (a) that in the absence of a materially changed international economic situation no change in the Agency's effort be made.
- (b) that the situation be reviewed in January 1953.
