

Many thanks for your kind letter of March 18 enclosing your son Jonathan's research paper. It is a very interesting paper. There is a wealth of data on the activities of American espionage and intelligence during the Revolution and I am working to get it published as part of our Bicentennial project.

I do note in the paper on page 26 the comment "To funnel off Whiskey taxes to themselves. Shades of the C.I.A.!" I can't say that I agree with this. No one has produced a shred of evidence to indicate that anyone in C.I.A. was trying to make money for himself individually or for the Agency, and I repeat, despite all the innuendo, no evidence has been produced to justify the indictment of a single member of this organization. There is a lot of loose talk, but no evidence to corroborate criminal activity as so freely bandied about.

Thanks again for your thoughtfulness and if Jonathan is ever in Washington I would be glad to talk to him about U. S. intelligence.
