



1. [Redacted] SKM) LIAISON Took a call from Jack Ticer, Senate Armed Services Committee staff, who wanted to know the members of the Committee staff who had attended the 19 February 1975 hearing in which the Director testified. I told him they were Ed Braswell, Clark McFadden, and Edward Kenney.

2. [Redacted] DFM) LEGISLATION Called Tom Smeeton, on the staff of the House International Relations Committee, regarding the proposed Harrington Amendment to the International Security Assistance Act of 1975, which would eliminate covert action. I arranged to deliver some materials which Representative William Broomfield (R., Mich.) could use in opposing the amendment in Committee.

3. [Redacted] WPB) LIAISON Received a call from Peg Cuthbertson, Press Assistant to Senator Alan Cranston (D., Calif.), and gave her the names and terms of office for the last four Directors.

4. [Redacted] WPB) HEARINGS Sat in on Richard Helms' testimony before the Senate Government Operations Committee, which is holding hearings on oversight of the Intelligence Community. Senator Abraham Ribicoff (D., Conn.) stated that mark-up of oversight legislation will commence February 16.

5. [Redacted] RJK) LIAISON Spoke with John Holstien, on the staff of the House International Relations Committee, who advised that Representative John H. Buchanan (R., Ala.) would be unable to be present at the briefing scheduled for him at 4:00 p.m. tomorrow. He requested that we reschedule the briefing for 4:00 p.m. on Tuesday, 3 February, in Representative Buchanan's office. I told him I would be back in touch. [Redacted] who will be handling the briefing, and [Redacted] office, OCI, have been advised.

[ ] RJK) LIAISON Spoke with Clyde Mark, on the staff of the Congressional Research Service, Library of Congress, concerning his earlier request for information on the military strength of the Palestine Liberation Organization. He said the figures we provided helped to confirm his own research on the subject.

25X1 7. [ ] PLC) LIAISON Accompanied [ ] OC/NED/DDS&T, who briefed Paul Leventhal, David Hoffmeister and Connie Evans, staff members of the Senate Government Operations Committee. The briefing concerned the proliferation of nuclear energy materials and information was for background use in connection with a bill on proliferation introduced by Senator Abraham Ribicoff (D., Conn.). See memo prepared by [ ]

25X1 8. [ ] PLC) LEGISLATION Called Bob Hull, Department of State, and requested loan of material he has prepared explaining State's funding of their legislative proposal for the Foreign Service Retirement program. He said he would appreciate any comments we might have which may be of assistance when they make their presentation on their bill later in this session of Congress. The material will be forwarded to Tom Yale and [ ] OF, for their review.

[ ] PLC) LEGISLATION Called George Gilbert, OMB, and informed him that the Director had sent a letter to Mr. Lynn, OMB, requesting that OMB forward the Agency's proposal to protect intelligence sources and methods to the Congress. Gilbert expressed some concern that OMB might not be able to get a decision from the White House in time to meet the request.

25X1 Later in the day, George Gilbert called me back to advise that OMB will not now be clearing the Agency's proposed legislation to protect intelligence sources and methods as the President has decided to personally submit the proposal to the Congress. It is not clear as to when the President will make his submission.

25X1 10. [ ] WPB) ADMINISTRATIVE - DELIVERIES Delivered a floor statement on Angola and comments from a newspaper column by Henry J. Taylor on detente to Ralph Preston, on the House Appropriations Committee staff.

12. [redacted] (RJK) LIAISON Received a call from

Clara Buchanan, on the staff of the Senate Foreign Relations Committee. She requested an updated Agency Chiefs of State publication, which I said we would send to her. She also requested a China atlas and I told her that none was available at this time but we hoped to have some before too long.

13. [redacted] (GLC) LIAISON John Goldsmith, Senate Armed

Services Committee Staff, called and asked if I would send a message to the field thanking [redacted] for the help he gave Goldsmith during his (Goldsmith's) recent visit to [redacted]. I told him I would be glad to send the cable.

14. [redacted] (GLC) LIAISON Mr. Lewis Hunter, GAO, called

again concerning the study GAO is doing on personnel overseas. I told him our people did not feel that they could talk about our staffing process without getting into substance. He asked if we could talk with his people so they could at least let us see what their study consists of. I told him I would pass his message on.

15. [redacted] (GLC) LIAISON Dorothy Fosdick, Senate Govern-

ment Operations Committee, called and asked about the footnote to the House Select Committee report which mentioned Senator Henry M. Jackson (D., Wash.). I told her basically what it said. I also told her we could find no record of the 24 February 1973 memo being transmitted to the House Select Committee. Ms. Fosdick asked if we would send her a copy of the footnote right away and I agreed to do so. She said the Senator should deny everything in the memo since he is not quoted correctly. She said it was obvious that there never should have been a memo on this kind of thing in the first place. I told her we had to keep records of things like this and that we were "damned if we do, and damned if we don't."

I later called Ms. Fosdick and underscored the fact that even though the footnote was not stamped with a classification, it should be handled as classified. She said she understood and would control it.

[redacted] - GLC) LIAISON Called Don Cogman, Senator Dewey Bartlett's (R., Okla.) staff, and told him that General Walters would speak to the 300 students from Oklahoma in Oklahoma City on 13 February. I said General Walters wanted to clear this with Ambassador Bush when he is on board, but we doubted there would be any problem. Cogman said he would wait to hear definitely from us. He asked if we could send him a picture and biography of General Walters, and I agreed to do so. 25X1

25X1 18. [redacted] GLC) BRIEFING Had several phone conversations with Bruce Van Voorst, Senator Dick Clark's (D., Iowa) staff, re their desire to have an Agency representative testify in open session on Thursday, following Dr. Kissinger, on U.S. interests in Angola. I did not seem to be making much headway in convincing Van Voorst that this was not a good idea, so I read him a letter I had drafted for Mr. Colby's signature, stating that, under the circumstances, he thought an appearance on Thursday would be inappropriate.

At the hearing I delivered to Mike Van Dusen, on the staff of the Subcommittee, an unclassified list of U. S. equipment which had been left in Vietnam at the end of the war, per his request.

23. [redacted] PLC) LEGISLATION Together with [redacted] OGC, met with Jim Cline, Counsel, Subcommittee on Immigration, Citizenship, and International Law; William Shattuck, Counsel, Subcommittee on Administrative Law and Governmental Relations, House Judiciary Committee, and discussed the private bill to compensate the [redacted]. We discussed the general thrust of the letters to be submitted by the Agency to the Chairmen of the Senate and House Judiciary Committees; however, Both expressed serious doubts that the bill has any chance of passage.


