Our meeting starts at 11:00 a.m., and I will meet you there at 10:30 a.m. I will be happy to provide transportation, if desired.



Our morning meeting is from 11:00 a.m. to 12:00 a.m., the last 15 minutes being reserved for questioning from the members.


We understand there is no fee, but would like to offer a \$25.00 honorarium.






