



"General Eaton, reportedly on General Sitton's instructions, has had prepared a fact sheet on our various projects for the purpose of briefing the new Secretary of Defense. This paper is to be given to Andrew Marshal as a channel to the new secretary.

I have told General Eaton's Action Officer Captain Carr that we do not concur in this. I have told Carr that this is a matter which should be brought before the Steering Panel which meets next Wednesday (Duckett will attend). This should be a Steering Panel decision and not a unilateral action by the O/JCS people. NSA and DIA agree although I am not aware of what action they are taking nor how effective it will be.

It would help, if you have the time, to call General Sitton and get him to relax. I am not at all sure that Marshal is the channel to use to the new secretary nor how many people will see the fact sheet who shouldn't if Marshal tries to run the ball.
