MEMORANDUM FOR THE DIRECTOR OF CENTRAL INTELLIGENCE:

SUBJECT: Survey of the Soviet Union Radio Broadcasts

1. Reference is made to MID 00.77 U.S.S.R., MEMORANDUM FOR THE DIRECTOR OF CENTRAL INTELLIGENCE, SUBJECT as above, dated 4 June 1947.

2. Intelligence Division desires to release, on a continuing basis, to the [redacted] Intelligence Division, copies of "Survey of U.S.S.R. Radio Broadcasts" and also other "Special Reports" of a similar nature, which are classified "Restricted." Although these publications are now being received by Intelligence Division, present Department of the Army policy prevents release of classified publications, produced by other United States Government agencies, without prior security clearance from the issuing agency.

3. Therefore, it is respectfully requested that Intelligence Division, General Staff, U. S. Army, be authorized to release copies of "Survey of U.S.S.R. Radio Broadcasts" and "Special Reports" to the [redacted] [redacted] on a continuing basis.
