SUBJECT: Committee to Study War Department Intelligence
Activities.

1. The addressees listed above are designated by the Secretary of War as a committee to meet at the call of the Chairman for the purpose of advising the Secretary of War regarding War Department and Army intelligence matters.

2. The committee is directed immediately to examine into the present organization, functions and responsibilities of all units in the War Department, and the three major elements of the Army engaged in intelligence activities, with a view to determining whether they are adequate, whether and to what extent duplication (either within or without the War Department) exists, how any duplication may be avoided, and how great a coordination can be accomplished.

3. The committee is directed to submit to the Secretary of War a report setting forth its recommendations as to the organization that should exist within the War Department and the Army to meet adequately their intelligence requirements. This report should be submitted not later than December 1, 1945.

4. In making its report the committee shall assume the continuance of the present over-all organization of the armed services into two Departments, War and Navy, but cognizance should be taken of the practicability of fitting the plan into a single Department of Defense of three divisions, Army, Navy and Air. The committee may also assume the creation of a national intelligence authority and central intelligence agency along the lines recommended in the report of a special committee to the Secretary of War dated 3 November 1945, which report was approved by the Secretary of War on November 6, 1945, but cognizance should be taken of the possibility that the creation of such a central authority and central agency may be disapproved or deferred by higher authority.

Chief, Strategy and Policy Group, OPD and Army Planners Joint and Combined Staff Planners; Chief, WD Orientation Course, General Staff, first six months of 1942; Hqrs, SOS, ETC one year; Deputy Chief, Strategy and Policy Group, Operations Division, WDGS, 1-1/2 years; Chief, Strategy and Policy Group, Operations Division, WDGS, and Army member, Joint and Combined Staff Planners for past year.

BRIGADIER GENERAL LOUIS J. FORTIER,

Artillery Commander, 94th Inf. Div.: G-3 representative on secret mission to Paris in 1937; ordered to Belgrade, Yugoslavia, as military attache, March 1939. Headed Western European Section of G-2 from May 1941 to 8 December 1941; organized Joint Intelligence Committee with assistance of Navy and Air Forces and served as senior Army member from 8 December 1941 until February 1942; Artillery Commander of 94th Infantry Division since 25 June 1942.

BRIGADIER GENERAL GEORGE C. McDONALD,

A-2, Headquarters, U. S. Air Forces in Europe; Air Attache to England 1939 to 1941; returned to U. S. and worked in G-2 and A-2 and with General Donovan for six months organizing OSS; A-2 for Eighth Air Force in England; A-2 of Twelfth Air Force in Africa; A-2 of Northwest African Air Forces; A-2 of the Mediterranean Allied Air Force; A-2 of the U. S. Strategic Forces in Europe; at present, A-2 of Hqrs, U. S. Air Forces in Europe.

BRIGADIER GENERAL THOMAS D. WHITE,

Commanding General, Seventh Air Force; Chief, U. S. Air Mission to Brazil from beginning of war until March 1942; G-5, Third Air Force to June 1942; Chief of Staff, Third Air Force to December 1943; Assistant Chief of Air Staff, Intelligence, to September 1944; Deputy Commander, Thirteenth Air Force, September 1944 to June 1945.

BRIGADIER GENERAL CHARLES Y. BANFILD,

Chief, Air Information Division, A C of A S - 2: Plans and Training Branch of G-2 from January 1941 until June 1942; Commandant of Military Intelligence Training Center at Camp Ritchie, Maryland, until 2 January 1945; European Theater of Operations as Director of Intelligence, Deputy Commander for Operations and Deputy Commander of the Eighth Air Force until July 1945; Hq., Army Air Forces for further duty with Eighth Air Force until August 1945.

G-2 language student in Japan 1922 to 1924; subsequently assistant military attache, student at Japanese General Staff College, and military attache in Tokyo; Assistant Chief, Far Eastern Section, MIS, fall of 1936; Chief, FES, MIS; Chief, Intelligence Br., G-2, 1937; transferred to 3rd Army, fall of 1943, AC of S, G-2 in Plans Group G (to prepare plans for movement into and occupation of Berlin) February 1945; occupied Berlin with 2nd Armored Div.; AC of S, G-2, U. S. HQ, Berlin, until 16 September 1945 when ordered back to U. S.
