

SUBJECT: Disposition of the Psychological Operations Coordinating
Committee.

The Operations Coordinating Board approved at its meeting of November 4, 1953, the recommendations of the Board Assistants with regard to the above Committee, one recommendation being that the Board would review the situation in the light of operating experience, no later than February 1, 1954.

The opinion of this Agency has been asked by your office with regard to the continuance or not of the POC.

It is the belief of this Agency that the POC is no longer necessary, and the Agency accordingly recommends that the OCB dissolve POC.

This Agency has arrived at the above conclusion on the basis of the following factors:

1) POC has not met in almost ten months. During that time no situation arose, in our opinion and apparently in that of other members of POC, which produced any demand that POC should meet.

2) POC was founded as a result of NSC 59/1 dated March 9, 1950. This was prior to the constitution of the Psychological Strategy Board, the predecessor to OCB. Following the establishment of PSB the lines of demarcation between PSB and POC were confused. Members of this Agency who attended POC meetings subsequent to the formation of PSB recall that long discussions were held at various meetings solely on jurisdictional questions.

3) Since the formation of OCB on more clearly defined lines than PSB, OCB, in our opinion, has effectively taken cognizance of matters frequently handled by FOC in the past. One of the Board Assistants' recommendations approved by OCB on November 4th was that:

"FOC-type problems involving the coordination of overt foreign information activities will, if not resolved directly among the agencies concerned, be handled for the time being as normal OCB agenda items."

In the two-and-a-half months since this OCB approval, it is felt that the FOC-type problems mentioned have been handled effectively as normal OCB items.

4) This Agency believes that the Board Assistants and the various panels set up under OCB can effectively handle most FOC type problems, and OCB can handle the remainder.

5) It is believed that to reconstitute FOC would create an element of confusion with regard to OCB itself and would lead to time-consuming jurisdictional discussions,
