I wrote to Admiral Hellenkott
in 1950, but never received
any satisfactory consideration,
and I wrote you from Columbia
S.C. in 1950 but did not hear
from you. you will give this
matter your careful attention.

my forced services, I'm sure
that you agree that eight
years is too long for any
ones salary to be held up.
it sounds like Russia.

NOTE FOR RECORD: Basic states: I am writing to ask your aid in collecting wages due me from September 1943 to date. These wages are due me from a certain agency (very hush hush) that is engaged in Intelligence data and superior methods of communications. The course involves a great deal of psychological findings as well as years and years of tedious, laborious, and monotonous isolation, which makes it impossible to engage in any other work. At present because I have not received one penny toward maintenance I'm forced to live under conditions that are a constant threat to my health, and lack the tools for a forced twenty-four hour shift. I'm sure I've provided enough details here that will enable you to recognize this particular agency and trust you will give this matter your immediate attention. Hoping to hear from you at your earliest convenience, I remain very truly yours.
