


Thank you for your letter of 13 March expressing your willingness to come to Washington to discuss your offer to assist the Central Intelligence Agency on a part-time basis. I have discussed your offer at length with the appropriate staff members. However, in view of the short periods which you would be able to devote to the Agency, it is difficult to decide upon a project or assignment in which your time could be profitably employed.
