1. I have received word from several sources including your memo that military intelligence unit is being called into active service. As the Commanding Officer of that unit himself will be placed on active duty.

2. I believe he could be of value to us as a consultant in conjunction with our overall planning activities and I would like to be able to make use of his services on that basis. I imagine his unit when activated will be stationed in the Washington area.

3. Consequently I suggest that we do not take any action with respect to his recall to active duty.

4. I believe, however, that the subject of his security clearance is not altogether finished. The report which you sent me over a month ago left it somewhat up in the air. It is my personal belief that despite past irregularities this individual has entirely too much to lose to take any action which might place the reputation he has built-up for over the past decade in jeopardy.




2. In due course, please let me know how you plan to use him.
