

STAT I am advised that there is a young man on your staff by the name of [ ] who is very much needed for a specific assignment with this agency. The nature of this assignment is known to me and I assure you that it is of considerable importance in the national interest and is of an urgent nature.

STAT [ ] has told us that he is unwilling to leave his present organization without the full understanding and consent of yourself [ ] although he is most interested in coming to us for the assignment above mentioned.
