

Mr. dear Mr. Dulles,

Your telephone call early last Friday was certainly appreciated and I recognized your voice as you did mine. It brought to my mind our pleasant associations at the Peace Conference, Paris.

The General Accounting Office where I am employed is now going through a reorganization, abolishing several Divisions, downgrading hundreds, and creating demoralization in general.

Briefly, herein are some of my experiences and background, so you will be able to judge whether I may fit somewhere in your Agency. If it does and my services may be used I shall retire from my office, otherwise obtain its consent to reparation.

I have a college education, having

attended both West Virginia University² and Dickinson College, ten years banking experience, accounting and supervision of it at many of our largest Embassies, Special Disbursing Officer for all missions sent to Europe and South America by the President or Secretary of State.

I was closely associated with Colonel E. M. House and on the staff of General Tasker H. Bliss at the Supreme War Council, Versailles.

While with the Peace Commission in Paris, I was detailed by Secretary of State, Robert Lansing to Sir Eric Drummond in London to be business manager of the League of Nations at its inception in 1919.

In the General Accounting Office I have examined War, Navy, and Maritime Commission contracts, subcontracts, etc —


