1. [redacted] should not bother you further. Mr. Angleton had a talk with him and it appeared that [redacted] had told various people in New York about what he was up to and, furthermore, he was very anxious that CIA use its influence to get him better living quarters in [redacted]. During the conversation Mr. Angleton apparently came to the conclusion that [redacted] was not going to be an immediately useful man and, therefore, had called the whole deal off.

2. I asked how [redacted] reacted and Mr. Angleton said [redacted] expressed the hope that his warm friendship with Mr. Angleton would not be prejudiced. It was apparently left that if, at any future time, CIA thought it might be able to use [redacted] it would communicate with him and this seemed to be quite satisfactory to [redacted].
