Dear Mr. Zwirn:

Reference is made to your letter of 12 June 1947, addressed to the Director of Military Intelligence and having regard to the use of the name of this Agency in connection with a radio program. The subject letter has been forwarded to us as the office of primary interest.

The fact that you have submitted this request and the way it is phrased indicate your awareness that reference to intelligence matters should not be lightly handled. We appreciate your attitude and your offer to cooperate regarding public relations. Our experience, however, has convinced us that it is essential to the efficacy of our operations to avoid publicity, good or bad, and to become in effect the most silent of silent services. While the name proposed by you is not identical with the title of this Group, the connection would inevitably be established in the public mind and the events broadcast, however hypothetical, would be taken as indicative of our methods and operations. For these reasons, we feel we cannot give our permission to you to use the name "Central Intelligence Bureau". I regret we feel unable to cooperate fully, but I am sure you appreciate the necessity for this position.

We wish you every success in the production of your program.

Dear Sir:

We are interested in producing a radio show entitled "CONFIDENTIAL REPORT". The show is to be a dramatic mystery-type radio program, having as its base a fictitious Confidential Report from an American agent abroad, to the Central Intelligence Bureau in Washington.

The entire show will be fiction, and will not be presented to the listening audience as fact. Most of the stories will be mystery, rather than spy. However, we would greatly appreciate your permission to use the name "Central Intelligence Bureau" as the intelligence organization receiving the confidential report. We do not intend using the Bureau as an integral part of the story, nor describing any activities of the Bureau, which, of course, are secretive. The name will merely be used to lend an aura of semi-believability to the show, such as is done with the various F.B.I. and Treasury programs.

If it is possible for you to grant us permission to use the name "Central Intelligence Bureau" at the opening and ending of the program, we would appreciate it very much, and would cooperate whole-heartedly with you regarding any public relations job that you may wish to put across on the program.

Your New York office told us that we would probably have to travel to Washington to settle the matter personally. I shall be only too glad to discuss this matter with you or your representative at any time that is convenient.
