SUBJECT : Amended Terms of Reference for Ad Hoc Panel B,
"Inventory of Cold War Weapons"

1. The amended Terms of Reference for Panel B, which prescribes the preparation of a study to concentrate on hitherto neglected means of pressure and persuasion in order to frustrate the Soviet bloc blackmail tactics, have been noted by this Agency.
