SUBJECT: Invitation of Mr. Gray for CIA (OPC) attendance

In general, I believe that it would be useful for us to be geared in closely with the deliberations of the PSB staff, and that this invitation offers an excellent opportunity for us to accomplish this if we have the right man who can spare the time.
