

Item 7: You Wished to Inquire Concerning the Forthcoming Conversations with Yugoslavia on Economic Aid.

According to the [redacted] SE Division, there have been continuing quadripartite conversations involving the U.S., U.K., France, and Yugoslavia and concerned with economic and fiscal aid to Yugoslavia. Superimposed upon these continuing conversations has recently been a Yugoslav request for 430,000 tons of wheat. Discussions of this matter involve only the U.S. and Yugoslavia. I assume you wished to learn from General Smith the scope, agenda, etc. respecting this last matter.

Item 9: National Research Council Request for Transportation for Proposed Pacific Science Conference in Manila, November 1953.

You may wish to support this request with Mr. Kyes. I understand from the Pentagon that operations costs for such assistance would amount to \$40,560 plus stand-by costs and that accessions to this request also involve a problem of availability of suitable aircraft.
