Dear Mr. Patterson

I have discussed the program of World Action which you and Mr. Nickerson presented to me last week with a number of key officials in government. I think that I must say very frankly to you that the consensus seems to be that the exact program you outlined would not be advisable at this time.

I am sure I am as much opposed to governmental "brush--offs" as you are. Because of my strong feeling in this matter, I shall be glad to have your plan reviewed by appropriate and competent officials with a view towards obtaining specific comments which could be presented to you.

Do you have in written form the plan as wholly presented last week and, if so, could you send me a copy?

Let me repeat to you what I said last week. I think that your plan has many and varied possibilities. Perhaps as a result of the procedure I have outlined, there may come some constructive suggestions which would appeal to you.
