SUBJECT: Ad Hoc Committee to perform initial study on U. S. Policy toward Soviet and Satellite Service Attache Personnel in the United States

3. Discussion was held on the draft of the proposed policy as circulated by the Committee chairman on 31 July 1950. Comments of a minor nature were made and the draft was amended to include these comments. The draft as amended was approved by all members present; the Air Force member was not present at this meeting.

4. Discussion was then held on a letter of transmittal for the proposed policy. Amendments were made to the first portion of the Air Force memorandum of 17 July 1950, incorporating comments of the various committee members and the draft as rewritten was approved by all members present.

5. It was agreed that the letter of transmittal and the proposed policy draft would be circulated to all committee members prior to transmittal to the DCI by the Chairman.

6. Barring unforeseen circumstances it was not believed that any more committee meetings would be required.

SUBJECT: IAC Ad Hoc Committee to Develop a Recommended U.S. Policy Toward Soviet and Satellite Service Attache Personnel.

1. Reference is made to Memorandum of 31 July 1950, from [redacted] and to copies of drafts (a) "Recommended U.S. Policy toward Soviet and Soviet Orbit Official Representatives on duty in the U.S.", and (b) "Draft of Policy Towards Soviet Orbit Representatives in the U.S.".

2. The Office of the Assistant Chief of Staff, G-2, Department of the Army, concurs in the text of the draft cited in paragraph 1 (a) above, provided the restrictions are made effective gradually and over a period of time in order not to provoke the Soviets into violent retaliatory action.

3. As regards draft cited in paragraph 1 (b) above, the Office of the Assistant Chief of Staff, G-2, is of the view that the the first two paragraphs should be eliminated as they are not deemed necessary for the purposes of this study.

Subject: Recommended U.S. Policy Toward Soviet and Soviet Orbit Official Representatives on Duty in the U.S.

1. Having studied the latest revision on policy towards Soviet representatives, and without having seen the 4th paragraph of Air Force draft, 17 July 1950, I have the following comments:

a. In view of the known picayunish obstructionism inherent in the Communist mind, I would suggest that we prevent a flood of travel applications, filed solely to alert, needlessly, the Federal Bureau of Investigation, as well as to embarrass the agency concerned, by requiring official and immediate cancellation if the journey is not initiated.

b. We do not understand the second sentence in paragraph F. It applies only to the Defense Department representatives without restricting any other U.S. agency and yet the restriction emanates from IAC. The IAC should establish a general policy, from which the Defense Department can then coordinate the activities of the Military Services.

There is no essential difference in Soviet procedure concerning travel for Embassy civil and military personnel. Approximately one third inhabitable part of USSR is open for travel by Embassy personnel. The rest is closed. Those wishing to travel to any part of the open area must notify Foreign Office in advance, (War or Naval Ministry in case of military members). They then proceed to try to buy railroad or plane tickets through Soviet travel agency. If they succeed this means that Foreign Office has permitted the travel; if Foreign Office hasn't approved they won't get the tickets, the excuse generally being that tickets sold out. This procedure means that Foreign Office need give neither written nor oral permission before departure.

Travel by all means including auto is permitted without prior notification within radius 50 kilometers (40 miles) from Moscow except 10 forbidden raions covering two thirds of area. Auto travel to three specifically named historical points beyond 30 mile limit is permitted provided prior notification is given and travellers do not leave main roads.
