C.I.G. DIRECTIVE NO. 14

REORGANIZATION OF THE CENTRAL INTELLIGENCE GROUP

Reference: N.I.A. Directive No. 5

Memorandum by the Director of Central Intelligence

1. In order to perform the functions assigned to the Director of Central Intelligence by N.I.A. Directive No. 5, the Central Intelligence Group is hereby reorganized as shown in the attached chart, effective 20 July 1946. Budgetary requirements for the attached organization will be submitted to the National Intelligence Authority for approval pursuant to paragraph 5 of N.I.A. Directive No. 5. All previous directives and orders regarding the organization of the Central Intelligence Group are hereby rescinded.

2. The detailed organization and activation of the various elements of the Central Intelligence Group will be announced by subsequent C.I.G. Administrative Orders, while personnel will be assigned by C.I.G. Personnel Orders.

DIRECTOR OF CENTRAL INTELLIGENCE

Inherent in existing law and the direction and control of Title 5, the Director of Central Intelligence performs the following functions as specified in the President's directive of 26 January 1962 and Title 5, Directive No. 1:

1. Acts as a non-voting member of the National Intelligence Authority.
2. Directs all activities of the Central Intelligence Group.
3. Formulates, evaluates and disseminates strategic and national policy intelligence within the Government.
4. Plans for coordination of intelligence activities related to national security and recommends to Title 5, overall policies and objectives to accomplish national intelligence purposes.
5. Performs services of common concern as directed by Title 5.
6. Performs other functions and duties related to national security intelligence as directed by the President and the Title 5.

DEPUTY DIRECTOR

Assists the Director in the discharge of his functions and acts for him in his absence.

INTERDEPARTMENTAL COORDINATING AND PLANNING STAFF

1. The Interdepartmental Coordinating and Planning Staff acts for the Director of Central Intelligence in the coordination of all intelligence activities related to the national security, and in the preparation of recommendations regarding the establishment of overall policies and plans to assure the most effective accomplishment of the national intelligence mission.
2. In discharging these responsibilities this staff will maintain continuous supervision of the planning and coordination of the intelligence activities of the Central Intelligence Group. It will focus its activities on the coordination of the intelligence activities of the State, War, Navy and other governmental departments and individuals concerned, to assure that:
 - a. The facilities of each activity are adequate to discharge its responsibilities;
 - b. All appropriate fields of intelligence endeavor are adequately covered;
 - c. The facilities of the Central Intelligence Group are operating to provide the best possible service to the State, War, Navy and other governmental departments and individuals concerned;
 - d. Raw information from all sources and activities is received by the Central Intelligence Group and, where appropriate, promptly distributed to the State, War, Navy and other governmental departments and individuals concerned;
 - e. The intelligence requirements of the State, War, Navy and other governmental departments and individuals concerned are adequately met;
 - f. Methods, procedures and controls are adequate within the Central Intelligence Group and the State, War, Navy and other governmental departments for the expeditious collection and integrated research and evaluation of information and for the prompt dissemination of strategic and national policy intelligence.

SECRETARIAT

Performs personal secretarial services for the Director of Central Intelligence and maintains for him a temporary office of record.

EXECUTIVE OFFICE

Functions as a staff for the Director of Central Intelligence in performing the normal duties of an executive office in planning, coordinating, administering and recording the activities of the Central Intelligence Group.

SECRETARY-NATIONAL INTELLIGENCE AUTHORITY

Performs secretarial for the National Intelligence Authority and the Intelligence Policy Group. Maintains coordination with the executive staff on appropriate matters.

OFFICE OF SPECIAL OPERATIONS
Asst. Director for Special Operations

1. The agency responsible for the performance of the functions assigned to the Director of Central Intelligence in paragraph 4a of NSA Directive No. 5.

OFFICE OF COLLECTION
Asst. Director for Collection

1. Acts for the Director of Central Intelligence in the collection of foreign intelligence information required for the production of strategic and national policy intelligence as it affects the national security of the United States.
2. In close coordination with the collection agencies of other governmental departments, determine the means and methods most appropriate for obtaining foreign intelligence information to enable the research and evaluation office, Central Intelligence Group to produce strategic and national policy intelligence.

OFFICE OF RESEARCH AND EVALUATION
Asst. Director for Research and Evaluation

1. The agency of the Director of Central Intelligence which studies and reports on the requirements for and produces strategic and national policy intelligence affecting the national security of the United States as required by the various departments of the Government.
2. In close coordination with appropriate intelligence divisions of participating governmental agencies, conducts the necessary review, research, analysis and integration of foreign information and intelligence, and evaluates the significance of trends and developments as they affect the national security.

OFFICE OF DISSEMINATION
Asst. Director for Dissemination

The agency of the Director of Central Intelligence responsible for the dissemination of evaluated strategic and national policy intelligence produced by the Office of Research and Evaluation, Central Intelligence Group.
