MEMORANDUM OF CONVERSATION

SUBJECT: State Department Sensitive Cables

The following understanding was reached:

- (a) Mr. Barnes gave permission for an OCI representative [redacted] I should think, or [redacted] to see sensitive cables which will continue to be sent to Jack Smith. This is to obtain during a dry run period in the preparation of the Daily Intelligence Summary.
- (b) A prospectus of the Daily or the Daily itself should be made available to Mr. Barnes for his information at the appropriate time to assist in solving the question of whether CIA is to get three copies (one for the Director one for O/NE and one for OCI which was our request).
- (c) There is to be no alteration in the present arrangements for State distribution of two copies to Jack Smith.

Reber's Comment:

The fundamental issue in the discussion seems to me to be this: Are these sensitive cables essential to the production of a Daily Intelligence Summary as background for those who produce it? Mr. Barnes thought not. [redacted] thinks they were necessary. It seems to me that only experience through the dry run arrangement indicated in (a) above can actually produce the answer to this issue. It is true of course, alternatively, that in the event Mr. Barnes cannot be persuaded in this way that General Smith could take the matter up with [redacted] My own recommendation would be that now is not the time for such action.

SUBJECT: Routing of Non-CIA Originated Cables

Copy No. 2 will be retained by OCI and will be seen only by the Assistant Director, OCI, and by those members of his staff directly concerned with the preparation of the DAILY SUMMARY. In any given case the total number of those in OCI who will need to see an "information only" cable should not exceed four. The No. 2 copy will be in the custody of the Editor, Mr. [REDACTED] No information contained in these cables will be directly included in the DAILY SUMMARY.
