The reference Progress Report by the Acting Secretary of State on the subject has been circulated for the information of the Council, and will be scheduled on the agenda of an early Council meeting.

The reference Progress Report by the Acting Secretary of State on the subject has been circulated for the information of the Council and will be scheduled on the agenda of an early Council meeting.

3. CURRENT NSC STAFF PROJECTS

A. SENIOR NSC STAFF

REAPPRAISAL OF UNITED STATES OBJECTIVES AND STRATEGY FOR NATIONAL SECURITY

(NSC Action Nos. 575 and 668; NSC 135/1 and Annex to NSC 135/1; NSC 135; Memo for NSC from Executive Secretary, subject, "United States Objectives and Programs for National Security", dated June 30, 1952; Two memos for NSC from Executive Secretary, same subject, dated September 2, 1952; Memos for Senior NSC Staff from Executive Secretary, same subject, dated September 5 and 8, 1952; NSC 114, 68 and 20 Series)

The Council on October 17, 1951 (NSC Action No. 575-g), directed the Senior NSC Staff to submit for Council consideration a reappraisal of the policies and programs set forth in the NSC 68 and 114 series, including a revision of Part I of NSC 114/2 and in the light of: (1) further analysis of Soviet atomic capabilities as indicated by the recent explosion of another atomic bomb in the USSR; and (2) the current evaluation of the net capability of the USSR to injure the continental United States (see "A Project to Provide a More Adequate Basis for Planning for the Security of the United States" in Section 4 below). Draft statement of policy on the subject, prepared by the NSC Staff pursuant to NSC Action No. 575, was submitted for Council consideration as NSC 135/1, which also contains for Council information an appendix comprising a "Summary and General Conclusions" resulting from the NSC Staff's reappraisal. A related NSC Staff study has been circulated as an Annex to NSC 135/1 for the information of the Council in connection with its consideration of NSC 135/1.

A memorandum by the President which sets forth his desires regarding the functions of the Council in relation to the determination of the programs and budget for FY 1954 was circulated by the reference memo of June 30 for Council information. The views of the Joint Chiefs of Staff and of the Chairman, NSRB, with respect to NSC 135/1 were transmitted by the reference memos of September 2 for the information of the Council. The Council, at its meeting on September 3, discussed NSC 135/1 and referred it to the Senior Staff for revision (NSC Action No. 668-a).

Draft revisions of NSC 135/1, proposed by the Office of the Director for Mutual Security and the FCDA, were transmitted by the reference memo of September 5, and other draft revisions proposed by the Acting Senior Defense Member were transmitted by the reference memo of September 8 for the consideration of the Senior NSC Staff. Awaiting reconsideration by the Senior Staff of NSC 135/1 at the Senior Staff meeting on September 9. (See also related project in Section 1 above and same subject in Section 4 below.)

CURRENT NSC STAFF PROJECTS (Cont'd)

CONDITIONS FOR A PEACEFUL SETTLEMENT WITH THE USSR ✓PRIORITY PROJECT

(Records of Senior NSC Staff Meetings February 23 and May 23, 1951; NSC 79; NSC 112; NSC Action No. 511; Memo for NSC from Executive Secretary, subject: "United States and Allied Objectives in the Event of Global War", dated September 6, 1950)

On February 23, 1951, the Senior NSC Staff agreed that the NSC 79 project on United States and allied war objectives should be completed in two sections and that the section on the above subject, including a plan for reduction and regulation of armaments and armed forces, should be completed as a matter of priority. On May 24, 1951, the Senior Staff agreed that the completion of this project would provide an important background for obtaining popular support for U. S. national security policies.

Report by the Secretaries of State and Defense in connection with the plan referred to above, adopted by the Council (NSC Action No. 511) and approved by the President as NSC 112. On July 10, 1951, the Senior NSC Staff noted that NSC 112 was the first step toward completion of this project and that further work would proceed in the light of Council action on NSC 112. Awaiting re-examination by the Senior State Member of this project and the one below, with a view to expediting their completion or proposing their cancellation.

UNITED STATES AND ALLIED WAR OBJECTIVES IN THE EVENT OF GLOBAL WAR

(NSC 79; Memo for NSC from Executive Secretary, same subject, dated September 6, 1950)

JCS memo (NSC 79) circulated for Council information and referred to the Staff for use in the preparation of a report. The Senior Staff designated an ad hoc group to draft a report to include both a statement of war objectives in the event of global war, and such related questions as a statement of the conditions that the U. S. would be willing to accept for a peaceful settlement with the USSR and its satellites. At the initial meeting of the ad hoc group under the chairmanship of the State Member on October 6, 1950, the form and content of a response to the problems posed by NSC 79 were discussed and agreed upon.

CURRENT NSC STAFF PROJECTS (Cont'd)

UNITED STATES AND ALLIED WAR OBJECTIVES IN THE EVENT OF GLOBAL WAR (Cont'd)

On February 23, 1951, the Senior Staff agreed that this project should be divided as follows: (1) a statement of U. S. and allied war objectives in the event of a global war; and (2) a statement of the conditions the U. S. would be willing to accept for a peaceful settlement with the USSR, including a plan for the reduction and regulation of armaments and armed forces. Awaiting re-examination by the Senior State Member of this project and the one above, with a view to expediting their completion or proposing their cancellation.

UNITED STATES OBJECTIVES AND COURSES OF ACTION IN KOREA
(NSC 118/2; Memo for NSC from Executive Secretary, same subject, dated December 18, 1951; NIE-55; SE-20; SE-27; NSC Action No. 595)

The Council in adopting NSC 118/2, referred the alternative versions of subparagraph 2-b-(6) to the Senior NSC Staff for review in the light of an analysis of the traffic in and out of Communist China and the probable effectiveness of an embargo or blockade (NSC Action No. 595-a-(4)). Awaiting preparation of a draft report by the Steering Committee on this project.

RELATIVE COST OF ENSURING AVAILABILITY OF CERTAIN MIDDLE EAST OIL FACILITIES OR OF OFFSETTING THEIR LOSS

(Record of Meeting of Senior NSC Staff on November 27, 1951; NSC 97/2; NSC 129/1)

The Senior NSC Staff at its meeting on November 27, agreed that, in connection with but not necessarily as a part of the Mediterranean and Middle East project (see NSC 129/1 and project on Iran below), the Department of Defense should prepare a study of the cost of the military effort in terms of feasibility, time and material, and the forces required to ensure the continued availability of oil from the Bahrein-Qatar-Saudi Arabia area, and the Office of Defense Mobilization should prepare a study of the economic cost in terms of feasibility, time and material required to offset the loss of oil from that area. Preliminary studies by Defense and ODM have been received by the Steering Committee on this project. The Steering Committee on April 29 agreed that consideration of this project should be deferred pending receipt of the forthcoming report on the national petroleum program (see NSC 97 project below).

Awaiting preparation of the report on the national petroleum program.

CURRENT NSC STAFF PROJECTS (Cont'd)THE POSITION OF THE UNITED STATES WITH RESPECT TO IRAN
(NSC 117; NSC 107/2; NSC 129/1)

Memorandum from the Joint Chiefs of Staff on "The Anglo-Iranian Problem", was submitted to the Council at the request of the Secretary of Defense as NSC 117. At its meeting on November 20, the Senior Staff agreed that NSC 117 should be listed in the Status of Projects as a reference in connection with the project on the Eastern Mediterranean and Middle East, rather than as a separate item. Subsequently the subject of the latter project was changed from the "Eastern Mediterranean and the Middle East" to "The Area of the Arab States, Iran and Israel."

The Senior Staff at its meeting on March 6 in connection with a discussion of a draft report on "United States Objectives and Policies With Respect to the Area of the Arab States, Iran and Israel During the Period of the Cold War" agreed that this draft report should include the Arab States, Israel and the Middle East Command (adopted by the Council as NSC 129/1), but not Iran, which was to be covered by the forthcoming revision of NSC 107/2. Awaiting preparation of a draft revision of NSC 107/2 by State. (See also related project above.)

UNITED STATES POLICY TOWARD FORMOSA, THE CHINESE NATIONALIST GOVERNMENT AND OTHER ANTI-COMMUNIST CHINESE FORCES

(NSC Action No. 624; NSC 128; NSC 48/5; Memo for the Senior NSC Staff from Executive Secretary, same subject, dated April 24, 1952; SE-29)

The Council on April 2 (NSC Action No. 624): (a) discussed the reference report by the Acting Secretary of Defense on Formosa (NSC 128); and (b) directed the NSC Staff, after preliminary discussion by the Departments of State and Defense and CIA, to prepare a report for Council consideration in the light of a review of NSC 48/5, insofar as it pertains to United States policy toward Formosa, the Chinese Nationalist Government, and other anti-Communist Chinese forces and in the light of the views of the Joint Chiefs of Staff contained in NSC 128.

The Senior Staff at its meeting on April 29 discussed the subject on the basis of the reference memo of April 24 reporting the results of the preliminary discussions pursuant to NSC Action No. 624-b, and constituted the Steering Committee on NSC 128, consisting of the Senior State, Defense, MS, JCS and CIA Members, to prepare for Senior Staff consideration a draft of the report called for by NSC Action No. 624-b in the light of the preliminary discussions. Awaiting preparation of a draft report by the Steering Committee on NSC 128.

CURRENT NSC STAFF PROJECTS (Cont'd)

A NATIONAL PETROLEUM PROGRAM

(NSC 97 and NSC 97/2; Memos for Senior NSC Staff from Executive Secretary, subject: "World-Wide Demand and Supply of Petroleum in Event of a Major War", dated August 3 and October 8, 1951 and February 27 and March 17, 1952; Record of Meeting of Senior NSC Staff of August 16, 1951; Memos for Senior NSC Staff from Executive Secretary, same subject, dated August 20 and October 24, 1951 and July 24, 1952; Memo for NSC from Executive Secretary, subject, "Security of Certain Middle East Areas", dated December 11, 1951; NSC Action No. 592)

At the direction of the President, a letter from the Acting Secretary of Defense on the subject (NSC 97) was referred to the Director of Defense Mobilization to develop a national petroleum program leading to the complete supply of allied requirements for consideration by the NSC. Interim report on the subject (NSC 97/1), prepared by the NSC Staff based largely on studies by ODM and PAD, was amended by the Council and submitted to the President on December 12 (NSC Action No. 592). The President on December 13 approved the Interim Recommendations contained in NSC 97/1, as amended, and directed their implementation by all executive departments and agencies of the U. S. Government under the coordination of the Director of Defense Mobilization. Report as amended subsequently issued as NSC 97/2.

At the request of the Senior ODM Member a "Refining Supplement" to the basic report transmitted by the reference memo of August 3 and a report on "Petroleum Transportation in the United States" which also supplements this basic report have been transmitted by the reference memos of February 27 and March 17 for the information of the Senior Staff. Report by the Senior State Member on developments in foreign countries in connection with planning for petroleum allocations and rationing was circulated for Senior Staff information by the reference memo of July 24. Awaiting preparation of a revised report by the Petroleum Administration for Defense on world-wide demand and supply of petroleum in the event of a major war, to serve as the basis for a re-examination of NSC 97/2 by the Senior Staff.

(NSC Action Nos. 575 and 668; NSC 135/1 and Annex to NSC 135/1; NSC 135; Memo for NSC from Executive Secretary, subject, "United States Objectives and Programs for National Security", dated June 30, 1952)

The Council, at its meeting on September 3, discussed NSC 135/1 and referred it to the Senior NSC Staff for revision (see NSC 135/1 project in Section 3-A above). The Council also noted that the President directs the Secretaries of State and Defense and the Director for Mutual Security jointly to undertake, in consultation as appropriate with other departments and agencies, the preparation of materials necessary for a reexamination of the amounts and allocations of resources to various areas in terms of kind, quantity, timing and priority, to determine: (1) whether a general increase in the level of free world programs and military forces is required to deal with the several threats; (2) whether the present allocation of resources as between U. S. military forces and other free world forces is appropriate; (3) whether the present balance between military assistance and the various types of economic assistance is appropriate; and (4) whether these allocations are in proper relationship to the threats facing the United States in Europe, the Far East, and the Middle East, to the importance of these areas for U. S. security, and to United States commitments.

The materials so prepared, together with any recommendations, are to be submitted to the President, through the NSC, prior to January 1, 1953, with a progress report to be submitted by November 15, 1952, if the work has proceeded sufficiently. Awaiting joint report by the Secretaries of State and Defense and the Director for Mutual Security.

UNITED STATES OBJECTIVES AND COURSES OF ACTION WITH RESPECT TO JAPAN

(NSC 125/2; NSC Action No. 660; Memo for NSC from Executive Secretary, same subject, dated August 7, 1952)

In connection with the President's approval of NSC 125/2 he directed that the general structure of a U. S. program to implement the courses of action enumerated in paragraph 7 thereof should, where suitable, be explored by the Departments of State in consultation with the Departments of Defense and Commerce, the Office of the Director for Mutual Security, the Office of Defense Mobilization and other appropriate agencies,

and that the main elements of such a program should be reported back to the Council at the earliest possible time. Awaiting report by the Secretary of State.

IMPLICATIONS OF CONTINUED HOSTILITIES IN KOREA

(NSC 134; NSC 114 Series; Memo for NSC from Executive Secretary, subject, "United States Objectives and Programs for National Security", dated June 30, 1952)

At the request of the Secretary of Defense, his memorandum and its attachment on the subject were submitted for Council consideration as NSC 134. The Director, Bureau of the Budget, has been invited to participate with the Council, the Secretary of the Treasury and the Acting Director of Defense Mobilization in action on this report. Awaiting reconsideration by Defense prior to Council action thereon.

ELIGIBILITY OF FOREIGN REPRESENTATIVES TO RECEIVE CLASSIFIED INFORMATION

(Memos for NSC from Executive Secretary, same subject, dated June 14, and November 19, 1951; NSC Action No. 507; Progress Report, dated December 20, 1951, by the NSC Representative on Internal Security on NSC 17/4 and 17/6)

Memorandum by the Chairman, Interdepartmental Committee on Internal Security (ICIS), and attached draft Presidential directive together with a report and proposed regulations on the subject, were transmitted by the reference memo of June 14, 1951, for consideration by the Council, the Secretary of the Treasury, the Attorney General, the Director of Defense Mobilization and the Chairman, Atomic Energy Commission. Approved by ODM, June 19; by Justice, June 21; by State, June 28; by Treasury, June 29; by NSRB, July 2; by AEC, July 9.

The Acting Secretary of Defense on July 2, 1951, recommended that the Council defer action on this memorandum until the Standing Group of the NATO has had an opportunity to examine the proposed regulations. On July 11 the NSC agreed that further consideration should be deferred, pending the outcome of the NATO negotiations as recommended by the Acting Secretary of Defense (NSC Action No. 507)

Memorandum from the Office of the Secretary of Defense and its attached report on the present status of negotiations within NATO were circulated by the reference memo of November 19 for the information of the Council, the Secretary of the Treasury, the Attorney General, the Director of Defense Mobilization and The Chairman, Atomic Energy Commission. In accordance with the proposal by the Department of Defense in the first sentence of the memorandum, the draft Presidential directive and related papers on the subject, transmitted by the reference memo of

ELIGIBILITY OF FOREIGN REPRESENTATIVES TO RECEIVE CLASSIFIED INFORMATION (Cont'd)

June 14, were referred back to the ICIS for reconsideration in the light of this memorandum from the Department of Defense. Awaiting report by the ICIS.

A PROJECT TO PROVIDE A MORE ADEQUATE BASIS FOR PLANNING FOR THE SECURITY OF THE UNITED STATES

(Memos for NSC from Executive Secretary, same subject, dated June 5, July 17 and 30 and August 7, 1951; NSC Action Nos. 519 and 543)

Memorandum by the Chairman Interdepartmental Committee on Internal Security, and its attached report by the ICIS on the subject, were transmitted by the reference memo of June 5, 1951, for Council consideration of the "Recommendations" contained in Part VII thereof and of the proposed National Security Council Directive. Prior to Council Action, at the direction of the President, the views of the Director of Central Intelligence were requested and transmitted by the reference memo of July 17 for consideration by the Council concurrently with the ICIS report. JCS views submitted by the reference memo of July 30.

At its meeting on August 1, 1951, the Council agreed to the four steps proposed by the JCS in paragraph 3 of the reference memo of July 30, subject to the assignment of paragraph 3-b to the Interdepartmental Intelligence Conference. The Council also agreed that the resulting reports should be integrated into a single report to it under the coordination of the Director of Central Intelligence with the assistance of representatives of the appropriate departments and agencies. The Director of Central Intelligence undertook to prepare a directive along these lines for consideration by the Council.

Draft directive on the subject, prepared by the Director of Central Intelligence was approved by the Council, the Secretary of the Treasury, the Attorney General and the Director of Defense Mobilization (NSC Action No. 543). Awaiting report by the Director of Central Intelligence.

ORGANIZED EVACUATION OF CIVILIAN POPULATIONS IN CIVIL DEFENSE
(NSC Action No. 651; NSC 131 and NSC 131/1; Memo for NSC from Executive Secretary, same subject, dated June 9, 1952)

As requested by the Deputy Federal Civil Defense Administrator, a draft Policy Memorandum by the Federal Civil Defense Administration on the subject, was transmitted as NSC 131 for consideration by the NSC of the policy contained in paragraph III thereof. A revised version of the draft Policy Memorandum by FCDA,

which incorporated changes accepted by the FCDA as a result of discussion in the Senior NSC Staff, including those changes contained in the reference memo, was transmitted to the Council as NSC 131/1. Supporting staff study prepared by the FCDA was also transmitted by the reference memo for Council information. The Council at its meeting on June 18, with the Federal Civil Defense Administrator participating, discussed NSC 131 and NSC 131/1 and deferred action thereon (NSC Action No. 651). Awaiting further study by the Federal Civil Defense Administration in the light of the discussion at the Council meeting.

EXAMINATION OF BAGGAGE OF INCOMING DIPLOMATIC PERSONNEL AND
SHIPMENTS TO DIPLOMATIC MISSIONS IN THE U. S.
(NSC 133)

Report by the Interdepartmental Committee on Internal Security on the subject, together with its accompanying memorandum from the Chairman, ICIS, was submitted in accordance with the last paragraph of the memorandum for the consideration of the National Security Council, the Attorney General and the Chairman, Atomic Energy Commission as NSC 133. Council action temporarily deferred at the request of the Department of Defense.

5. CANCELED PROJECTS

SECURITY OF STRATEGICALLY IMPORTANT INDUSTRIAL OPERATIONS IN FOREIGN COUNTRIES

(NSC Action Nos. 670, 610 and 531; Memo for NSC from Executive Secretary, same subject, dated August 20, 1952; NSC 29; Progress Reports, dated July 24, 1951 and January 21, 1952, by the Department of State on NSC 29)

By NSC Action No. 531, the Council referred the reference Progress Report on July 24, 1951, to the Senior NSC Staff for recommendation regarding the desirability of a revision of the list of operations contained therein and the frequency of future progress reports by the Department of State.

By NSC Action No. 670, the Council canceled the Directive to the NSC Staff contained in NSC Action No. 531 and noted that the Department of State will continue to transmit progress reports on the subject as significant developments occur.
