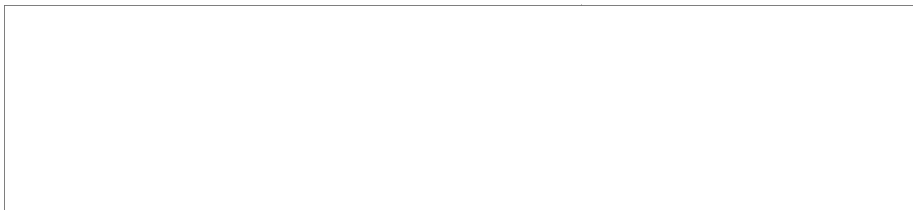

Foundation and Tasks of Transmitter and Receiver Section

1. "The Transmitter and Receiver Sections were formed in basic organizations /SRJ/ of minimum three members.
2. "The main purposes of Transmitter and Receiver (T/R) sections are:
 - a. To enable the members of SRJ continuous technical improvement and the action in development and perfecting of T/R radio technique.
 - b. To meliorate the staff of good radio amateurs and receivers who through their activities would improve the expansion of amities and cooperation between the nations.
3. "The entire work of T/R sections is based on the spirit and aims fixed by the statute SRJ.

Membership and the Matter of Action

4. "Every acting member of SRJ can become a member of T/R section if after the examination, he receives permission from his country committee to work in T/R section.
5. "The rights of a member of T/R section are:
 - a. To frequent courses organized by T/R sections.
 - b. To take advantages of all privileges foreseen by these statutes.

6. "The duties of members of the T/R sections are:
- a. To be constantly among the most active members of T/R sections.
 - b. To put, in case of need, his technical knowledge at the disposal of the Yugoslav Army, National Authorities, and scientific institutions.
 - c. To be active in execution of all rules and instructions regulating the T/R sections dealing and to prevent the misuse of radio communications for purposes other than amateurish ones.
7. "A member of T/R sections ceases to pertain to it:
- a. By voluntary stepping out of section.
 - b. By decision of Radio Club of Management Committee or of Superior Instances of SRJ.
8. "The activity of T/R sections consist of:
- a. Courses, lectures and discussions which all tend to lift up the level of knowledge of members in camp of transmitting and receiving of radio technology.
 - b. Practical construction of different receiving and transmitting sets.
 - c. To maintain radio contact with home and foreign radio amateurs.

Management

9. "The Federal Committee SRJ leads the entire activity of T/R sections. Its competence includes the following:
- a. The issue and change of statutes concerning the T/R sections and different dispositions in this connection.
 - b. The distribution of permits in accordance with competent organs for installation action of all radio amateur station and also the distribution of operators attests.
 - c. The official representation of SRJ in relation with foreign radio amateurs organizations.
 - d. Organization of competition between members of T/R sections in Federative Peoples Republic of Yugoslavia.
 - e. Manages the work of the Amateurs Radio Station YUIA.
 - f. Emits Yugoslav diplomas of international validity.
 - g. Organizes QSL activity.
 - h. Organizes control activity whose duty is to control the correct work of Yugoslav amateurs.
10. "Transmitter and receiver sections on the territories of singles republics are governed by the country committees. The following belongs to their activities:
- a. Emissions of permits for foundation of T/R sections and admittance of single members into T/R sections.
 - b. Organization of commissions for holding examinations of all grades in T/R sections.

- c. Emission of cyphers to amateur receivers for their receivers cyphers.
 - d. Organization of competition of T/R section members in their republics.
 - e. Emission of individual operators temporary permits to use the portable radio amateurs station outside of their permanent residence.
 - f. Emission of permits for phonic connections on foreign languages.
11. "The Executive Committee governs the T/R sections of Radio Club. Between other matters he proposes the establishment of sections and also gives his opinion about the admission of candidates in the section.

Classification of Operators

12. "Every member of T/R section bears the name of operator. Operators are:
- a. Operators apprentices and
 - b. Operators of the IIIrd, IInd and Ist class.
13. "In order to become operator apprentice and at the same time member of a T/R section, member of SRJ it is essential to fulfill the following conditions:
- a. To be acquainted with the statutes and instructions for manipulation of T/R sections.
 - b. To dispose with the knowledge of medium/B/Radio Amateurs Course.
 - c. To tip and receive Morse alphabet with the speed of 60 letters per minute.
 - d. To know the most indispensable amateurs and international abbreviations and other regulations regarding radio amateurs traffic.
 - e. The member must be at least 16 years old.
14. "Operator apprentice is transferred into the IIIrd class when he proves with cards that he has made connections with 25 different countries.
15. "A IIIrd class operator is transferred into the IInd class on fulfillment of the following conditions.
- a. That he has mastered the material of higher ~~amateurs~~ class.
 - b. That he tips and receives by audition 80 letters in a minute
 - c. That he possesses a confirmed radio amateurs contact with 60 different countries.
 - d. That he is of age.
16. "A IInd class operator is permitted into the Ist class on fulfillment of the following conditions.
- a. That he tips and receives by audibility 100 letters in a minute.
 - b. That he possesses confirmed contact with 100 different countries.
17. "Telephonic communications on foreign languages are permitted to operators only after examination that they have sufficient knowledge of respective language for amateurs practice.

18. Operators must keep the following allocation of the wave lengths in kHz:

3500 - 3650 CW for operators apprentices III, II and I class
 3650 - 3800 CW for all classes ICW, PHONE for I, II and III class.
 7000 - 7100 CW for operators apprentices III, II and I class.
 7100 - 7150 CW ICW and PHONE for II and I class.
 14000 -14150 CW for III, II and I class.
 21000- 21200 CW for III, II and I class.
 21200 -21450 CW for III, II and I class, ICW and PHONE for II and I class.
 28000 -28200 CW for III, II and I class.
 28200 -29700 ICW and PHONE for II and I class.

To all operator classes the work is permitted to CW, ICW and Phone on following ultra short waves mHz:

144 - 146	2300 - 2450
420 - 460	5650 - 5850
1215 -1300	10000 -10500

19. Distribution of inputs /product of anode current and anodic current density last V.F transmitters degree /on operator classes is the following:

- Operators apprentices - 25 watts.
- IIIrd operators class - 25 watts.
- IInd operators class - 50 watts.
- Ist operators class -120 watts.

20. Operators apprentices and IIIrd class operators are entitled to work exclusively on club stations, whereas the Ist and IInd class operators can work on their own receivers-transmitters.

V. Calling signals and QSL service.

Calling signals for all amateurs stations are distributed by the Federal Committee SRJ.

21. All amateur radio stations on the territory of Federal Peoples Republic Yugoslavia bear the prefix YU and the respective republic serial number in this order: Serbia 1, Croatia 2, Slovenia 3, Bosnia and Hecegevina 4, Macedonia 5, and Montenegro 6.

Besides the prefix and the republic number and the signals of the IIIrd, IInd and Ist class operators are bearing two letters.

Operator apprentices are using the calling signal of their club radio station, which besides the prefix and the republic number have also three letters.

22. When an operators is working outside of his radio station, he is obliged to add the letter P to his signal, and when he happens to be outside his republic, then he instead of the letter P must use cypher which in amateur's calling signal designates that republic.

23. Members of T/R sections are obliged to confirm each connection with a QSL card. In order to facilitate the QSL traffic, the Federal Committee SRJ is organizing QSL bureau which is receiving QSL cards from foreign countries and distributes them between the operators and vice versa. The form of organization of QSL bureau and its activity will be designated by instructions.

24. On the territory of Federative Peoples Republic of Yugoslavia only one QSL bureau can exist.

VI Technical instructions,

25. Operator in his amateur activity is obliged to strictly follow the fixed wave lengths and calling signal as well as the other regulations of radio amateur communications prescribed by the international convention and agreements.

26. "The maximum allowed modulation depth is by modulated telegraphy 3%. On work the extension of amplitude modulated telephony is limited on 5. The maximum allowed range for frequency modulated telephony on - UKT is 15 kHz.
27. "Musical emission for control of modulation is allowed only for five minutes in one circuit.
28. "Alternatively current or not sufficiently filtered current must not be used for filling anodes and anode screening grids of emitting powers. Modulation which occurred on alternating component current must not overpass five per cent.
29. "The emissions have to be practically free of all parasitic oscillations.
30. "Adjustments and coordination of antenna must not disturb the emission of other amateur stations and has to be done during the time of feeble activity on the wave.
VII Other Regulations
31. "Operator is compelled on presenting his petition to the Federal Committee SRJ for permit for his radio station to enclose its plan. In the same way if changing his transmitter and receiver disposals he has to present to Country and Federal Committees SRJ the plans of new disposals.
32. "On submitting petition for license the operator is obliged to give the exact address of location of his radio station. In case of shifting his transmitting station, operator has to apply to Federal Committee SRJ for a new license for the new location /QTH/.
Inasmuch as the operator wants to work with his station for a short time outside the permanent place of his station, he must have a separate permit issued by respective Country Committee giving place and time for which the permit is valid.
33. "Every operator is bound to keep diary of his work. All technical particulars regarding the obtaining of contacts have to be entered in this diary. The diary must be kept one year after its issue has ceased.
34. "Operator must not allow the use of his radio station to persons who have no regular license.
35. "Active SRJ members residing in places where no condition for existence of a T/R station are can pass the examination for IIInd class straight on. Every such case has to be dealt by the Federal Committee with separate decisions.
36. "An operator, who during the previous six months has committed a greater violation of these statutes and was condemned, cannot be promoted into a higher operators class.
37. "An operators diploma must by the end of every year be legalized by the Federal Committee SRJ.
The legalization is effected on the basis of Federal Committee of Radio Club's opinion regarding operator's activity as member of that radio club. The operators diploma will not be legalized to non-active members who did not contribute in the development of their club except in justified cases, illness and similar. A non-legalized diploma means at the same time the end of membership in T/R section.
38. "Emissions of radio amateurs station in possession of licenses have to be limited to technical contents and be in accordance with the aims of radio amateur movement here and abroad. The emission can be done in plain language or with international abbreviations established for radio amateur communications. It is not allowed the use of code signals nor the transmission of telegrams and

information which does not belong to the competition of postal or other public service. In the same way it is not allowed the use of radio amateur connection for the trade or speculative purposes.

39. "The emissions of radio amateur stations must not disturb the reception of radio emitting station on receivers of good quality. If such a thing occurs then an operator is obliged to stop his emission until the disturbances which he has caused to others have been set aside.
40. "Every operator is bound to answer to a call for help given on amateur waves from any station, and keep contact until the interested parties are informed about it.
41. "Commissions of all sorts of examination in T/R section have to consist of at least three members who must be specialized enough for such examinations. The Country Committee has to confirm the establishment of each commission.
42. "Members of radio amateur service are entitled to control the diaries of work and transmitter and receiver aggregates of each member of T/R section.
43. "Each operator is obliged to pay a special tax to Country Committee which has to be fixed by the same committee because as a result of three months non-payment means the loss of membership in T/R section.

VIII. Final Regulations

44. "Every violation of these regulations will be punished according to its gravity. The punishments are:
 - a. Written monition.
 - b. Temporary withdrawal of operators diploma for one to six months time.
 - c. Expulsion from T/R section

The Executive Committee of Radio Club, the Country Committee and the Federal Committee have the right of punishment.

The board that sentences the verdict has to supply the copy of the verdict with comments to the interested higher or lower instance/Radio Club, Country Committee, Federal Committee/.

Each punishment to be communicated in writing to operator who has committed violation and in case of his expulsion from T/R section or punishment with temporary prohibition of working on a transmitter, the Executive Committee is bound to withdraw his operator's diploma. Within ten days from receipt of verdict, the operator has the right to complain in writing to the Federal Committee of SRJ, whose decision is final.

45. "The course of action on passage from the old to the new statute of T/R section will be explained by the instructions for commentary on these statutes.
46. "The right to comment, change and supplement these statutes belongs exclusively to the Federal Committee SRJ.
47. "The regulations are entering into force on the 1st of December 1951, and on that day all previous regulations and instructions which are not conformed with these statutes, lose their validity."
