

Approval of Minutes

1. Action: The minutes of the last meeting, 24 January 1952, (IAC-M-57) were approved.

Probable Developments in Iran in 1952 in the Absence of an Oil Settlement. (NIE-46)

2. Action: Approved as modified.

Intelligence in Saigon

3. Discussion: Mr. Armstrong noted in connection with paragraph 4 of the last minutes that the Department's instruction to Saigon (repeated to Paris) regarding intelligence on Indochina and the comment from Paris had been made available to the agencies. In this connection Admiral Johnson noted that the ~~quarterly~~ ^{periodic} meetings between British, French and U. S. Military intelligence in Singapore, and particularly the forthcoming subcommittee meeting, might be of possible value in respect of Indochina intelligence. He concurred with General Smith that it would be desirable in the future for the CIA representative in Indochina to attend these conferences.
