2. Action: Approved as amended.


Probable Soviet Bloc Courses of Action Through Mid-1955

4. Action: The members agreed that the specific problems of foreign publication and map procurement raised in Mr. Armstrong's letter (Tab A to the document) were of concern to their agencies and that maintaining the flow of publications and maps at approximately present levels was essential to their operations.
