a. The report was noted.


b. The Chairman suggested, and the members agreed, that in the future these reports be prepared at the end of each fiscal year.





7. Unless objection is raised by a member at the next regular meeting of the IAC, SNIE 30-3-55, "Probable Consequences of the Egyptian Arms Deal with the Soviet Bloc," 12 October 1955, will not be released to any foreign government.

8. The Board of National Estimates recommends that a Post-Mortem is not required on NIE 100-7-55, "World Situation and Trends," 1 November 1955. This estimate is highly speculative, and intelligence deficiencies concerning the countries and areas of the world covered in the NIE have been noted previously. No Post-Mortem will be undertaken, therefore, except at the request of a member at the next regular meeting of the IAC.
